PROCEEDINGS:

In the Board's Proceedings first read above, among other things orders were issued allowing 27% of Dearness Allowance to the pensioners/family pensioners of Tamil Nadu Electricity Board with effect from 1.7.2009. In the Government Order second read above, the Government of Tamil Nadu have revised the rates of Dearness Allowance payable to their Pensioners/Family Pensioners with effect from 1st January 2010. The Tamil Nadu Electricity Board has decided to adopt the Government Orders to the Pensioners/Family Pensioners of the Tamil Nadu Electricity Board also.

2. Accordingly, the Tamil Nadu Electricity Board directs that the Pensioners/Family Pensioners of the Tamil Nadu Electricity Board shall be paid Dearness Allowance with effect from 1st January 2010 at the following rate:

Date from which payable	Revised rate of Dearness Allowance (Per month)
1 st January 2010	35 % of Pension/Family Pension

3. The increase in dearness allowance drawn from 1st January 2010 shall be paid in each to the Pensioners/Family Pensioners. The amount of Dearness Allowance involving a fraction of a rupee shall be rounded off to the next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

 In the case of divisible family pension, the Dearness Allowance shall also be paid proportionately.
