**PROCEEDINGS:**

In the proceedings first read above, orders were issued allowing 119% of Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited with effect from 01.07.2015. In the Government Order second read above, orders have been issued revising the rate of Dearness Allowance from 119% to 125%, payable to its Pensioners/Family Pensioners with effect from 1<sup>st</sup> January, 2016. It has been decided to extend the same benefit to the Pensioners/Family Pensioners of TANGEDCO also.

**2.** Accordingly, it is hereby ordered that the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited, be paid Dearness Allowance with effect from 1<sup>st</sup> January, 2016 at the following rates:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1 <sup>st</sup> January, 2016	125% of Pension / Family Pension.

**3.** Consequent to the increase in the rate of Dearness Allowance from 119% to 125%, the arrears for the period from 01.01.2016 to 31.03.2016, as ordered in para-2 above shall be paid to the Pensioners/Family Pensioners along with the pension/family pension for the month of April 2016.

**4.** The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

**5.** In the case of divisible family pension, the Dearness Allowance shall also be paid proportionately.

**6.** The receipt of these proceedings shall be acknowledged.
