PENSION – Dearness Allowance to Pensioners and Family Pensioners Revised rates of Dearness Allowance from 1st January, 2015 – Orders - Issued.

PROCEEDINGS:-

In the proceedings first read above, orders were issued allowing 107% of Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited with effect from 1.7.2014. In the Government Order second read above, orders were issued revising the rate of Dearness Allowance from 107% to 113%, payable to its Pensioners/Family Pensioners with effect from 1st January, 2015. It has been decided to extend the same benefit to the Pensioners/Family Pensioners of TANGEDCO.

2. Accordingly, it is hereby ordered that the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited, be paid Dearness Allowance with effect from 1st January, 2015 at the following rates: -

Date from which payable	Revised rate of Dearness Allowance (per month)
1 st January, 2015	113% of Pension/Family Pension.

3. Consequent on increase in the rate of Dearness Allowance from 107% to 113%, the arrears for the period from 1.1.2015 to 30.4.15, as ordered in para-2 above, shall be paid to the Pensioners/Family Pensioners on **11.05.2015**.

4. The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

5. In the case of divisible family pension, the Dearness Allowance shall also be paid proportionately.

6. The receipt of these proceedings shall be acknowledged.
