1. (Per) CMD TANGEDCO Proceedings No.9 (SB), dated 19.01.2022.

2. G.O.Ms.No.257 Finance (Pension) Department, dated 18.08.2022.

PROCEEDINGS:

In the Proceedings first read above, among other things, orders were issued allowing 31% of Dearness Allowance to the Pensioners/Family Pensioners of Tamil Nadu Generation and Distribution Corporation Limited with effect from 01.01.2022.

<u>2.</u> In the Government Order second read above, orders have been issued revising the rate of Dearness Allowance from **31% to 34%**, payable to the Pensioners/Family Pensioners of the Government with effect from **1st July, 2022**. It has been decided to extend the same benefit to the Pensioners/Family Pensioners of TANGEDCO.

<u>3.</u> Accordingly, it is hereby ordered that the Pensioners/Family Pensioners of TANGEDCO, be paid Dearness Allowance with effect from 1^{st} July 2022 at the following rates:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1 st July, 2022	34% of Basic Pension/Family Pension.

<u>4.</u> The increased rate of Dearness Allowance from 31% to 34%, ordered in para-2 above, shall be paid to the Pensioners/Family Pensioners along with the pension/family pension from the month of November 2022.

5. Consequent on increase in the rate of Dearness Allowance from 31% to 34%, the arrears for the period from 01.07.2022 to 31.10.2022 (i.e. from July to October) as ordered in para-2 above, shall be paid to the Pensioners/Family Pensioners on **05.11.2022**.

<u>6.</u> The amount of Dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee, if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

<u>7.</u> In the case of divisible Family Pension, the Dearness Allowance shall also be paid proportionately.
