### PROCEEDINGS:

The Government of Tamil Nadu, in its G.O. second read above, have issued orders sanctioning further instalments of Dearness Allowance to the Ex-gratia beneficiaries with effect from 01.07.2009 to 01.01.2013. In the Proceedings first read above, among other things, orders have been issued sanctioning Dearness Allowance at the rate of 65% to the Contributory Provident Fund/Non-pensionable establishment beneficiaries of TANGEDCO who are in receipt of Ex-gratia payment of Rs.605/- per month plus Dearness Exgratia with effect from 01.07.2009. Hence, the need for extension of the benefit of enhancement of the rates of Dearness Allowance to the ex-gratia beneficiaries of TANGEDCO on par with the ex-gratia beneficiaries of Government of Tamil Nadu with effect from 01.01.2010 to 01.01.2013, has been examined. After careful consideration, it has been decided to accept the same.

2. Accordingly, it is hereby ordered that the rates of Dearness Allowance to the ex-gratia beneficiaries of TANGEDCO, be sanctioned with effect from 01.01.2010 to 01.01.2013, at the rates mentioned below:-
