PROCEEDINGS:

In the Proceedings first read above, orders have been issued sanctioning Dearness Allowance at the rate of 248% and 256% with effect from 1st July 2016 and 1st January, 2017 respectively, to the Contributory Provident Fund/Non-pensionable establishment beneficiaries of TANGEDCO who are in receipt of Exgratia payment of Rs.645/- per month plus Dearness Exgratia with effect from 04.06.2013. The Government of Tamil Nadu, in the Government Order second read above, have issued orders sanctioning Dearness Allowance to the Exgratia beneficiaries with effect from 01.07.2017. After careful consideration of the orders of the Government, it has been decided to adopt the same.

2. Accordingly, it is hereby ordered that the Dearness Allowance to the Exgratia beneficiaries of TANGEDCO, be enhanced with effect from 01.07.2017 at the rate mentioned below:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1 st July, 2017	260%

3. The Exgratia beneficiaries of TANGEDCO are entitled for the arrears of Dearness Allowance at the rate ordered in para-2 above with effect from 01.07.2017. The payment shall be made immediately.

4. The receipt of these proceedings shall be acknowledged.
