Sub : TANGEDCO – Tamil Nadu Electricity Board Pensioners' Health Fund Scheme – Exercising the option by the existing Family Pensioners – Extension of time limit – Orders - Issued.

Following the orders of the Government, orders have been issued in the reference first cited, extending the Tamil Nadu Electricity Board Pensioners' Health Fund Scheme to the Family Pensioners who are willing to enroll themselves under the scheme on or before nine months from the date of issue of the orders (i.e. up to 17.09.2011), by deducting the monthly contribution of Rs.75/- p.m. from the Family Pension and in the reference third cited, orders were issued enhancing the monthly contribution towards the said Scheme from Rs.75/- to Rs.100/- per month. On considering the request of the Pensioners' Associations of TANGEDCO, in the Memo. second and fourth cited above, the time limit for exercising the option by the Family Pensioners were extended.

2. Certain willing Family Pensioners and Pensioners' Association have again requested to extend the time limit to enroll them in the aforesaid scheme. The said request has been carefully considered and decided to accept the same.

3. It is hereby ordered that the time limit be extended to exercise the option by the Family Pensioners for enrolling themselves in the Tamil Nadu Electricity Board Pensioners' Health Fund Scheme (erstwhile Tamil Nadu Electricity Board) up to **31.1.2014**. Further, it is also ordered that no further extension of time in this regard would be entertained. If no such option is received from the existing Family Pensioners on or before the prescribed time limit, it will be construed that they are not willing to enroll themselves under the scheme. The other conditions prescribed in this regard remain unaltered.
