PROCEEDINGS:

In the Board's Proceedings first read above, orders were issued to the effect that the pensioners of Tamil Nadu Electricity Board including family pensioners/exgratia beneficiaries shall furnish Life Certificate, Non-employment Certificate and Non-remarriage/Non-marriage Certificate in the respective proforma at any time during the months of April, May and June every year to the Pension Disbursing Officer concerned after duly getting it attested by the Bank Managers of the respective Branch where the Pensioners/ Family Pensioners/Exgratia beneficiaries receive pension/family pension/exgratia or any Gazetted Officer of the State or Central Government duly adopting the orders of the Government.

2. In the Government Order second read above, orders have been issued prescribing new formats for Life Certificate with photo, Non-employment/Re-employment Certificate and Non-remarriage/Non-marriage Certificate to be furnished at any time during the months of April, May and June of the year to the Pension Disbursing Officer concerned after duly getting attested by an attesting authority or at the 'time of annual mustering. In the Government Order third read above,

orders have been issued dispensing with the attestation of Gazetted Officers in the Non-employment/Re-employment Certificate and Non-remarriage/Non-marriage Certificate placing the entire responsibility of the genuineness of the declaration with the Pensioner/Family Pensioner concerned, due to self declaration given by them. The same has been considered for adoption.

- 3. Accordingly, it is hereby ordered that the Pensioners including Family Pensioners/Exgratia beneficiaries shall furnish the Life Certificate with Photo, as in Annexure-I after duly getting it attested by the Bank Managers of the Branch where the Pensioners/Family Pensioners/Exgratia beneficiaries receive pension/family pension/ exgratia, along with Nonemployment/re-employment Certificate and Non-remarriage/Non-marriage Certificate in the respective proforma as in Annexure-II and III, at any time during the months of April, May and June every year to the Pension Disbursing Officer concerned. If the pensioners/family pensioners/exgratia beneficiaries do not produce the above certificates on or before 30th June, the Chief Internal Audit Officer shall call for annual mustering of the pensioners/family pensioners/exgratia beneficiaries during the month of July every year. If the pensioners/ family pensioners/ exgratia beneficiaries neither produce Life Certificate, Non-employment/Reemployment Certificate and Non-remarriage/Non-marriage Certificate nor appear for annual mustering, the Chief Internal Audit Officer shall stop the payment of pension/family pension/exgratia with effect from the month of August and the payment of pension/family pension/ exgratia will resume only on production of the said certificates or the pensioner appearing in person before the Chief Internal Audit Officer. The attestation of Gazetted Officers in the Non-employment/Re-employment Certificate and Non-Remarriage/Non-marriage Certificate is dispensed with. However, the entire responsibility of the genuineness of the declaration rests only with the Pensioners/Family Pensioners/Exgratia beneficiaries concerned due to self declaration given by them.
- 4. The orders issued in this Proceedings shall be given effect to, from the year 2016.

5. Receipt of this Proceedings shall be acknowledged.
